"MANILA, Philippines — Broadcast giant GMA Network Inc. is exploring opportunities outside the media space similar to the steps being undertaken by its rival network, its chairman and CEO Felipe Gozon said.

'Yes, there are plans. We are looking,' Gozon said when asked if GMA has plans to diversify its business just like what ABS-CBN has been doing recently.
