We write with respect to the news articles published in various newspapers on December 23, 2019. In the attached news article entitled "Govt finds GMA Network liable in actor's death; fined P890,000" posted in BusinessMirror (Internet Edition) on December 23, 2019, it was reported in part that:		
"THE Department of Labor and Employment (DOLE) has slapped GMA Network Inc. and its contractors with a fine of almost P900,000, saying the public-listed firm violated occupational and safety and health (OSH) violations in the workplace, which killed veteran actor Eduardo 'Eddie' Garcia earlier this year.		
On December 2, DOLE-National Capital Region (DOLE-NCR) ordered the media firm to pay a total of P890,000.		
Of the said amount, P810,000 will be for the supposed non-submission of GMA of the needed work accident/illness report (WAIR) to DOLE about the incident within the 24-hour period, DOLE-NCR Director Sarah S. Mirasol said.		
The company was also ordered to pay an additional P40,000 since there was no safety officer present in the site where Garcia's scene for the teleserye Rosang Agimat was shot. The other P40,000 was for the absence of a first-aid personne in the same site.		
GMA Network has received the copy of the Order dated December 2, 2019 issued by the Regional Director of the Department of Labor and Employment (DOLE) National Capital Regional Office. In response, the Network submitted an Appeal with the Secretary of Labor within the allowed period seeking to annul and reverse the said Order.		
GMA will proceed with the necessary steps as soon as the DOLE resolves its appeal.
