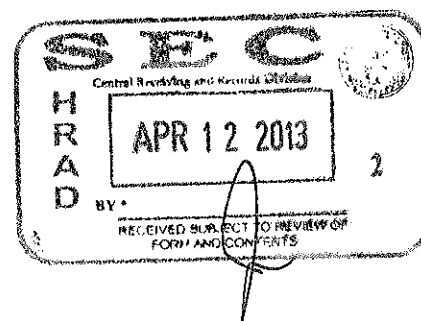

Re : GMA Network, Inc.'s 2012 GIS



Gentlemen:

We write on behalf of our client, GMA Network, Inc. (the "Company"), and refer to your attached letter dated March 18, 2013 (the "Directive") which we received last April 8, 2013, directing the Company to amend its attached General Information Sheet which was filed last June 14, 2012 (hereinafter "June 14, 2012 GIS"), to include the following:

- (1) Tax Identification Number (TIN) of some stockholders;
- (2) Type of License/Registration;
- (3) Date of Issuance of the Secondary License; and
- (4) Date the company started operations.

In compliance thereof, we hereby submit the Company's amended General Information Statement for the year 2012 and respectfully offer the following explanation for the absence of the foregoing information in the 2012 GIS filed last June 14, 2012:

a) **Tax Identification Number (TIN)**

Under p. 5 of the June 14, 2012 GIS, the Company provided for its top twenty (20) stockholders as well as the TIN of each of them except for two (2) stockholders: Jose P. Marcelo and Horacio P. Borrromeo, whose TINs, we could not procure despite having exerted diligent efforts to locate the same, which included among others calling the stock transfer agent due to the fact that the Company does not have direct access of the personal information of stockholders trading over the Philippine Stock Exchange (PSE).

Nevertheless, the Company has, in its corporate files, the addresses of Mr. Marcelo and Mr. Borrromeo to which we have already sent the attached letters requesting for their TIN numbers. In order to comply with the directive of this Honorable Office, we hereby undertake to submit an amended GIS upon receipt of their respective TINs.

Finally, the Company did not indicate the PCD Nominee TIN as the said entity only serves as only as a depository of scripless shares and is not a legal and beneficial owner of the same. Nonetheless, in order to faithfully comply with the Directive of this Honorable Office, we have indicated the PCD Nominee TIN in the attached amended 2012 GIS.

- b) **Type of License/Registration;**
- c) **Date of the Issuance of the Secondary License; and**
- d) **Date the Company Started Operations**

We no longer provided details of the foregoing information required in (b) (c) and (d) under p. 7, as we were of the honest belief in good faith that (b) and (c) are the same as the SEC Registration Number in p.1 of the June 14, 2012 GIS and that (d) is the same as the Date of Registration indicated also in p. 1 of the June 14, 2012 GIS. Thus, we were of the sincere impression that any other information required under the aforesaid portions of p.7 is not applicable anymore to the Company. However, upon receipt of the attached directive we immediately called this Honorable Office to seek clarification¹ and were informed that (b) and (c) actually refer to the registration of shares/securities and that (d) refers to the date when the Company in fact began operating its business and not when it was first registered.

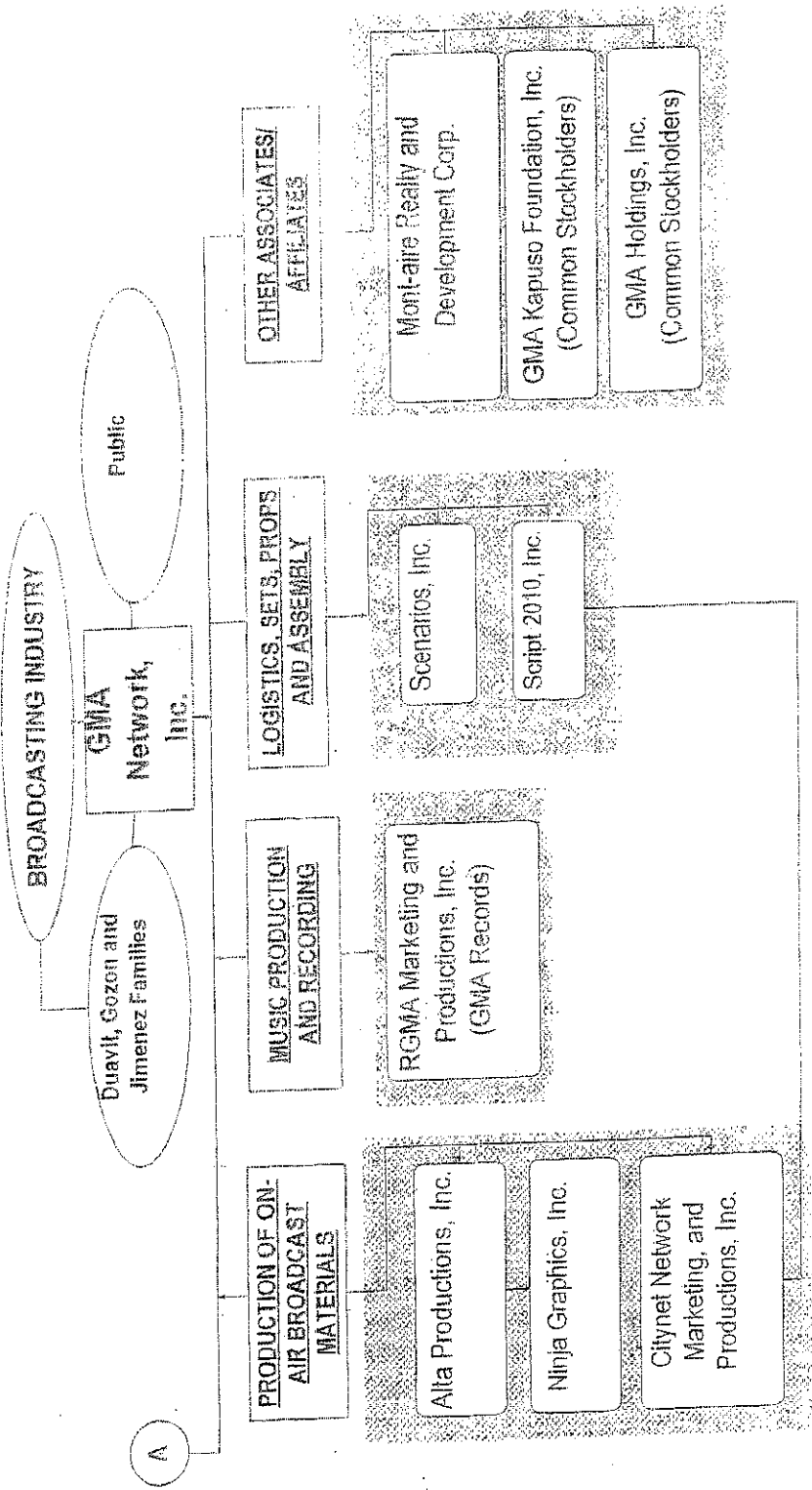
