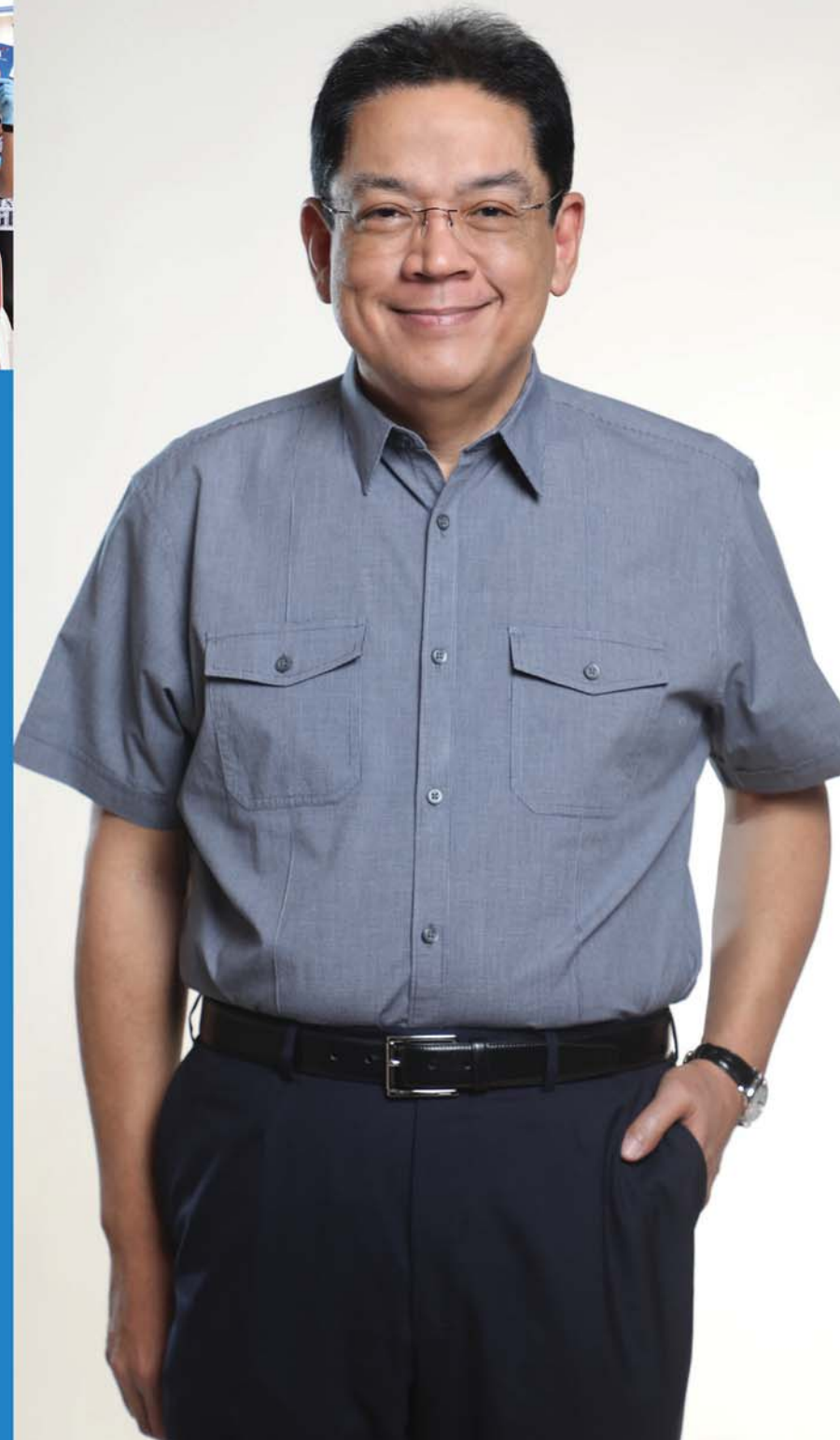
Message from the **PRESIDENT**

We have confronted many challenges over the years, but none have come close to the sudden and unexpected events of 2020. Taal Volcano erupted at the start of the year, affecting thousands of Filipinos. Very shortly after, the COVID-19 virus that was spreading across the globe entered our shores. As the entire country was reeling from the effects of the pandemic, consecutive typhoons came, unleashing winds and floods that destroyed homes, displaced families and claimed lives.

In the face of these calamities, the GMA Kapuso Foundation redoubled its efforts. Despite the numerous obstacles presented by the ubiquitous COVID-19 virus, the Foundation had served 408,251 individual beneficiaries nationwide by the end of the year.

When the pandemic hit, we launched *Operation Bayanihan: Labanan Natin ang COVID-19*, a public information campaign and disaster relief program which extended crucial aid to medical frontliners by supplying them with assorted PPEs (Personal Protective Equipment), as well as to locked down communities in Luzon by providing food packs and drinking water to families in need.

Through *Unang Hakbang sa Kinabukasan*, a pillar project of our education advocacy, we helped 70,000 public elementary school students from the 25 poorest provinces across the country and other areas hardest hit by the pandemic. Through a community-based approach, school bags containing complete school supplies along with hygiene kits were distributed to support the students with their study-from-home educational needs. The Foundation also successfully conducted another traditional, child-centric project, *Give A Gift: Alay sa Batang Pinoy*. Cognizant of the extraordinarily difficult times, given this year were Christmas grocery packs which brought cheer to 65,000 children from COVID-19 affected areas and their families. In observance of related restrictions and thus ensuring the safety of the children-

beneficiaries of both projects, distribution was made directly to their parents, in coordination with the relevant DepEd units and LGUs and in full compliance with prevailing quarantine, health and safety protocols.

We also continued to provide remote villages with safe access to basic services as well as local economic and government centers through our *Kapuso Tulay Para sa Kaunlaran* program. In October, the Foundation turned over a 40-meter, steel and concrete hanging bridge to the municipal government of Salvador, Lanao del Norte to benefit the residents of Bgy. Pansur.

Several projects we lined-up under our *Kapuso School Development* initiative were similarly successful. The construction of school buildings in Bgy. Pansur, El Salvador, Lanao Del Norte, Bgy. Cabatangan, Zamboanga City and Bgy. Patani, Marawi City were completed, together with the rehabilitation works done to school buildings in Prieto Diaz, Sorsogon, Sorsogon, Bgy. Bariw, Camalig, Albay and Bgy. San Rafael, Sorsogon. It is gratifying to note that all the mentioned school building projects were turned over to their respective local governments by the end of the year.


Even before the numerous typhoons hit, the Kapuso Foundation and its partners and volunteers were hauling, packing and loading relief goods in anticipation of swiftly

deploying these to affected families in different parts of North and Central Luzon, Metro Manila, Calabarzon, and the Bicol Region. As in the past, these preparations paid off very well as we were able to bring help as soon as the affected communities became accessible. Starting with the relief operations the Foundation conducted earlier in the year in aid of the victims of the Taal Volcano eruption in January, we were able to serve over 260,000 of our countrymen through our Disaster Relief efforts by year-end 2020.

The details of these and the other accomplishments of the GMA Kapuso Foundation in the past year can be found in this report. We invite you to read the succeeding pages as we proudly share with you how your help and generosity have enabled us to pursue our common mission of uplifting the lives of underprivileged Filipinos in these most trying of times.

Although it was a very difficult year for all, we witnessed how resilience, hope and courage overcame many challenges. This we saw, not only in our many beneficiaries but also in you, our most valued benefactors, partners and volunteers.

Message from the **EXECUTIVE VICE PRESIDENT/COO**

The year 2020 is unforgettable because it was the year we went through with bated breath. A volcanic eruption, a world wide pandemic and consecutive super typhoons, all in a span of one year, all requiring massive amounts of aid for millions of affected Filipinos.

GMA Kapuso Foundation is particularly known for its response in disaster relief via its Operation Bayanihan project. Donations from the public are used to purchase relief goods and GMAKF teams are pre-positioned to be able to respond as soon as a natural disaster is over, be it a storm comparable to a category 5 hurricane or a volcanic eruption not experienced in the last 40 years. But we faced a unique challenge in 2020. We have never experienced giving aid in the time of a pandemic where traditional means had to make way for necessary safety protocols. We were painfully conscious that aid giving could be a means of COVID transmission. We purposely went house-to-house in giving aid and implemented strict social distancing measures for residents who arrived in batches to fetch GMAKF provisions in pre-chosen open areas. Our safety supplies given to public hospitals were turned over in open air parking lots. To enforce order and safety protocols at our distributions, we called upon our partners in the Armed Forces of the Philippines (AFP) to help us in security and transport. We were not disappointed. GMAKF was able to implement our LABANAN ANG COVID 19 hospital and community distributions consistently and safely because of the men and women of the armed forces who were with us, every step of the way.

2020 Year At A Glance

In a year marked by the advent of the COVID-19 virus around the world, your GMA Kapuso Foundation continued to work for the needy and served a total of **408,251** individuals.

2020 saw...

268,447 beneficiaries served by GMAKF Disaster relief projects, included among which was our food and groceries distributions in COVID paralysed communities in the National Capital Region as well as other affected provinces in the Visayas and Mindanao.

70,000 beneficiaries served by our Education projects, particularly our Unang Hakbang Para Sa Kinabukasan school supplies distribution, at a critical time when education took a back seat to basic survival as people lost their jobs and regular income.

65,020 beneficiaries served by our Values Formation projects which include our Give-A-Gift Noche Buena distribution, Kapuso Cancer Champions project and our remote Sagip Dugtong Buhay mini blood letting campaigns in lieu of large scale, mall based blood letting events.

4,784 beneficiaries served by our Health Projects which were severely limited so as not to add to the quicker spread of the COVID-19 virus.



2020 is when GMA KAPUSO FOUNDATION implemented its Operation Bayanihan: Labanan Natin ang COVID-19 disaster relief operations wherein we gave crucial aid to medical frontliners and locked down communities in the National Capital Region/Luzon, Visayas and Mindanao. We are grateful to God, our partners, donors, sponsors and volunteers for making all these possible amidst the pandemic.

- **3,024** survivors of the eruption of Taal volcano were given relief goods in Calamba, Laguna

Annual Report 2020 Cover Story :

LABANAN NATIN ANG COVID-19

The Philippines was in the midst of coping with the aftershocks of the Taal volcanic eruption in January, 2020. We had scarcely regained our proverbial breaths but by month's end, a more pressing concern would grip the country and the entire world : the highly transmissible and deadly SARS COV2 virus had arrived from China and it would spread like wildfire.

Almost a month after China reported deadly pneumonia cases of unknown causes in Wuhan, the Department of Health (DOH) on January 30, 2020 confirmed that the Philippines had its first case of the Novel Corona Virus. It was no surprise that RP patient #1 was a Chinese citizen from Wuhan, then the epicentre of the new virus, who arrived via Hong Kong to vacation in the Philippines, in Cebu and Dumaguete. RP Patient #1 was an asymptomatic woman. A day later, on January 31, 2020, the World Health Organization (WHO) declared a global emergency after the Novel Corona Virus quickly spread to more than a dozen countries, the Philippines included. Finally, President Duterte ordered a ban on the entry of Chinese nationals from China's Hubei province and its capital, Wuhan. But COVID-19 had already gotten in. There was no shaking it off. On February 2, the Philippines recorded its first COVID death : a 44 year old male Chinese citizen who was admitted to the San Lazaro Hospital in Manila for pneumonia. End of February





came shocking news : 27 Filipinos on board the MV Grand Princess cruise ship had tested positive for COVID-19. The ship was quarantined off Yokohama, Japan. On March 7, the DOH confirmed the first case of local transmission of COVID-19. On March 15, 2020, ECQ (Enhanced Community Quarantine)/ lockdown is implemented in Metro Manila and the National Capital Region, the identified COVID red zone, restricting movement and economic activity. Domestic, land, air and sea travel to and from Metro Manila were suspended. On March 17, President Duterte declared a nationwide state of calamity, for a period of 6 months, unless earlier lifted or extended as warranted. It was shocking, unheard of, but painfully real. In a little over a month's time,

the unseen enemy, the COVID-19 virus had managed to shut down the National Capital Region. Millions of daily wage earners were left bereft and reeling. Now, the crisis was not just a health crisis but an economic one.

Despite our personal fear of contagion, your GMA Kapuso Foundation, buckled down with the Armed Forces of the Philippines to implement critical food and grocery distributions to daily wage earners and their families, badly affected by the COVID pandemic. GMAKF collected donations from private individuals and companies who wanted to help the less fortunate at this unprecedented, difficult time. "Fully loaded" grocery packs with rice, noodles, canned goods, condiments, bread, drinking water, juices, soap, shampoo, toothpaste as well as

hygiene kits with sanitizers, alcohol, face masks and face shields were distributed weekly to affected communities. March to August, the GMAKF LABANAN ANG COVID-19 community distributions continued week in and week out. Affected residents were not asked to line up. That would cruelly expose the needy to possible COVID-19 infection. Instead, GMAKF relied on the dedicated soldiers of our Armed Forces to go house to house and implement the critical food and grocery distributions, while adhering to strict safety protocols as mandated by the newly created IATF, Inter-Agency Task Force on Infectious Diseases, the governing body spearheading government response to the COVID-19 health crisis. Simultaneous to our community distributions of food and grocery packs were our distribution of safety supplies to public hospitals. Your GMAKF received an SOS from government hospitals whose frontliners were overwhelmed with the sudden surge of patients infected with COVID-19. Our frontliners working in public hospitals within the red zone, appealed for more safety supplies so they can avoid getting infected and continue to work to help the sick, get well again. GMAKF, again with its partners from the AFP, made weekly deliveries to public hospitals.

Tens of thousands of PPEs (Personal Protective Equipment), surgical and N95 face masks, face shields, isopropyl and ethyl alcohol, soap, ready to eat food, drinking water, supplements and hundreds of thousands of pairs of non-sterile rubber gloves were dropped off at no less than 131 public hospitals, nationwide.

After the ECQ (Enhanced Community Quarantine)/lockdown was lifted, GMA Kapuso Foundation's Labanan Ang COVID 19 community and hospital distributions served thousands of medical and service front liners as well as over twenty two thousand (22,000) needy families or over eighty nine thousand (89,000) individuals affected by the COVID-19 pandemic. May the good Lord be praised for this miraculous feat!

Joining Forces Against An Unseen Enemy: The Pivotal Partnership of GMAKF with The AFP, The PNP, The Philippine Coast Guard and The Philippine Red Cross, Against Covid-19

On March 15, 2020, all of Metro Manila, the National Capital Region (NCR) and eventually, the whole of Luzon, were placed under Enhanced Community Quarantine (ECQ), the strictest level of quarantine in which land, air and sea travel were strictly controlled in a bid to stop the spread of COVID-19. Under ECQ, strict home quarantine was implemented in all households and public transportation was suspended. There was the heightened presence of military personnel in borders of towns and provinces and the police in public places to enforce quarantine restrictions. President Duterte signed the Bayanihan Heal As One Act granting him special powers to help government deal with the nationwide health crisis brought by the pandemic. Under the law, millions of low income households would receive emergency subsidies amounting to 5-8 thousand pesos per month for two months. However, the pace of aid distribution was not consistent. Some cities and provinces were quick, others slow. Daily wage earners lamented their loss of income which made them unable to see to the needs of their families.

Wanting to respond to the cry for help of thousands of needy families, your GMA Kapuso Foundation was in a quandary --- how do we move safely amidst ECQ? GMAKF called on its partner, the Armed Forces of the Philippines, for help. Enacting a public service oriented memorandum of agreement with GMA Kapuso Foundation, the AFP moved its men, its trucks and tons of GMAKF relief goods for our joint LABANAN NATIN ANG COVID 19 community and hospital distributions. From repacking to hauling to enforcing IATF rules at actual distributions, the AFP's army, navy, airforce and marines, helped GMA Kapuso





Foundation reach thousands of needy households in the red zone of Metro Manila, NCR and nearby provinces. The PNP also supported the effort by likewise fielding its policemen to keep the order during GMAKF's weekly aid distributions. The PNP Medical Reserve Force stationed at the SM Mall of Asia Mega Swabbing facility and the Philippine Coast Guard manning the Palacio de Maynila Mega Swabbing Facility did their best to ensure the safety of our soldiers, policemen and GMAKF staffers by doing prompt testing after our exposure to communities where COVID infection rates are highest. The Philippine Red Cross laboratories processed our COVID swab test results as fast as they could, knowing that the sooner positive results are known, the sooner victims can be isolated, seek treatment, be cured and get back to public service work. By the grace of God, GMAKF was spared from rampant local transmission of COVID among its staff. Any infections were quickly identified, treated and thank heavens, we suffered no deaths, allowing us to continue with unabated weekly distributions all throughout the ECQ period. This, until GCQ or the looser General Community Quarantine was declared, finally allowing daily wage earners to return to work at vital industries.

In return, GMA Kapuso Foundation showed its grateful appreciation by augmenting the safety supplies of our men in uniform, thousands of whom were vulnerable to COVID infection, as they manned border crossings in and out of the capital and its linked cities. It was cooperation at its best, for God, for good and for the Filipino people! God bless our brave men and women in uniform, without whom we would not have been able to conduct safe, speedy and widespread aid distributions, nationwide.

Operation Bayanihan : Super Typhoons Rolly and Ulysses

The country was already reeling from the economic devastation wrought by the COVID-19 pandemic when the unthinkable happened : the strongest typhoon to hit the earth in 2020, Super Typhoon Rolly (International Code Name : Goni) slammed into Southern Luzon on the first day of November and 15 days later, the third strongest typhoon to hit the planet, Super Typhoon Ulysses (International Code Name : Vamco) walloped Metro Manila and Northern Luzon.

Super Typhoon Rolly packed maximum sustained winds of 195 miles per hour and first hit Catanduanes Island in the Bicol Region before barrelling into the rest of Bicolandia, Albay, Masbate, Camarines Sur and Sorsogon. Rolly left extensive destruction to life and property. 24 people were left dead and over 130 thousand people (130,266) were displaced. On the other hand, Super Typhoon Ulysses was only the 3rd strongest typhoon of 2020 but it had a worst impact on life, leaving 67 people dead. The eastern enclaves of Marikina and Rizal were left devastated, as were the northern provinces of Aurora and Cagayan Valley. The National Disaster Coordinating Council (NDRRMC) said the consecutive Super Typhoons wrought a total of 34.3 billion pesos in damages.

Your GMA Kapuso Foundation pre-deployed personnel in Camarines Sur and Albay before Super Typhoon Rolly hit. This allowed GMAKF, with the support of the Philippine Army's 9th Infantry Division and the Philippine Coast Guard, to reach the affected shortly after Rolly subsided. Relief goods, clean drinking water, hygiene kits, face masks, face shields and hot meals were distributed to over 42 thousand 300 individuals (42,344). Two weeks later, at the wake of the destruction left by Super Typhoon Ulysses, GMA Kapuso Foundation, with the help of soldiers of the Philippine Army's 5th and 2nd Infantry Divisions and the AFP's Joint Task Force-National Capital Region (JTF-NCR), distributed relief goods, clean drinking water, hygiene kits, face masks, face shields and hot meals to over 54 thousand 200 (54,268) beneficiaries in the affected provinces of Cagayan, Isabela, Ifugao, Aurora, Quezon, Rizal and the city of Marikina. We thank the Lord and our generous donors for helping make the quick distribution of aid to so many affected, possible.

Taal Volcano **Erupts**



On January 12, 2020, after 42 years of restive sleep, Taal Volcano erupted again. The last time Taal erupted was back in October, 1977. When it finally awoke in 2020, thousands of families living in enclaves close to it were displaced.

Taal Volcano started spewing on a Sunday. Alert level 2 was raised at 2 pm of that day but things escalated fast. By 4 pm it was alert level 3 meaning magmatic unrest was observed. The volcano's ash column had reached 1 kilometer by then. By 7:30 pm, Taal had reached the point of no return. Alert Level 4 was finally declared meaning a hazardous eruption was imminent. The ash and rock fragments column was already 10-15 kilometers high by this time due to the volcano's continuous eruption. Volcanic lightning was also seen. Later that evening, Taal's ashfall reached the rest of Calabarzon and Metro Manila. Larger particles of rock fragments from the volcano were also reported in the areas of Tanauan and Talisay in Batangas, Nuvali and Sta. Rosa in Laguna, and Tagaytay City.

The next day, January 13, the Philippine Institute of Volcanology and Seismology (PHIVOLCS) said a total of 144 volcanic earthquakes had been recorded in the Taal region since it first erupted on January 12, and warned that it may lead to "further eruptive activity."

By this time, the whole of Batangas was already placed under a state of calamity.

Your GMA Kapuso Foundation, with the aid of the Philippine Army's 2nd Infantry Division, immediately mounted an Operation Bayanihan relief distribution for affected families who sought shelter in evacuation centers. The eruption of Taal was unexpected and many left their homes only with the clothes on their back. GMAKF distributed food packs with rice, noodles, canned goods, bread, clean



drinking water and coffee as well as new clothing, hygiene kits with soap, shampoo and N95 face masks to protect residents from inhaling ash particles. Popular game show, WOWOWIN, which airs on GMA Network every afternoon and its host Willy Revillame, mounted a live fund raising program and raised enough funds to buy 1 million pesos worth of rice which was promptly turned over to GMA Kapuso Foundation for immediate distribution, along with thousands of relief packs donated by sponsors.

Taal Volcano continued with its eruption until the end of January, 2020. Your GMAKF conducted over 30 relief distribution forays in that span of time, serving over (12,000) twelve thousand families and over (51,000) individuals. On January 26,2020, PHIVOLCS finally downgraded Taal Volcano's status to Alert Level 3, but warned that the volcano remains very active and people should continue to be cautious. The Department of Agriculture estimated that the damages and losses caused by the eruption reached Php 3.06 billion pesos, affecting 15,790 hectares of arable land and 1,923 heads of livestock. The human trauma, on the other hand, is incalculable.

Kapuso School Development – Rebuild Mindanao



GMA Kapuso Foundation's Kapuso School development project serves as a disaster relief intervention through the construction of sturdy classrooms to replace dilapidated ones damaged by natural and manmade disasters.

In 2017, Mindanao was devastated by Typhoon Vinta and the Marawi siege. These unfortunate events prompted GMA Kapuso Foundation to build Kapuso schools in Lanao del Sur, Lanao del Norte and Zamboanga City under our Rebuild Mindanao Project.

Pansur Elementary School

Barangay Pansur, Salvador, Lanao del Norte

Typhoon Vinta badly hit the province of Lanao del Norte in 2017. It destroyed critical infrastructure such as bridges and schools.

Ms. Rikki Escudero-Catibog, GMAKF EVP/COO, leads the inauguration of Pansur Elementary School at Brgy. Pansur, Salvador, Lanao del Norte along with the Philippine Army led by General Gilbert Gapay, then AFP Chief of Staff, the Local Government Unit of Salvador & DepEd.



This prompted GMA Kapuso Foundation to conduct an ocular trip to Barangay Pansur in Salvador, Lanao del Norte. It was then that the GMA Kapuso Foundation team led by Ms. Rikki Escudero-Catibog, EVP/COO, came across children crossing a treacherous river with their GMAKF Unang Hakbang Sa Kinabukasan school bags. That sighting turned out to be providential. The old bridge was completely ruined by Typhoon Vinta which left the community of Christians and Muslims (Tausug) with no choice but to risk their lives in traversing the river, especially perilous during the rainy season.

Pansur Primary school was the nearest school to the community. When the kids graduate to elementary, they need to go to another public elementary school which is a far distance from their barangay. They cross the river and walk for over an hour to reach this elementary school. This urgent need to develop Pansur Primary to a full-fledged elementary school tugged at the hearts of the GMA Kapuso Foundation team.

A new building with 2 sturdy Kapuso classrooms was built, to add to the current classrooms of Pansur Primary School. The new building was inaugurated on October 9, 2020. It was constructed with the help of the Philippine Army's 2nd Mechanized Division, 54th Engineer Brigade and the local government of Salvador as well as private donors. These new classrooms will be used by Grades 4-6 pupils. Now, the new school is only a short distance from students' homes.

This Kapuso School Development project aims to provide a sturdy school for children where they feel safe. Education is indeed a ticket out of poverty which benefits the entire family.

Rebuilding Mindanao is not an easy feat but if we work together and put aside religious and cultural differences for others, the impossible becomes possible!

Patani Elementary School

Barangay Patani, Marawi City, Lanao del Sur

The successful Rebuild Dreams in Marawi campaign of GMA Kapuso Foundation and The Coffee Bean & Tea Leaf gave birth to the construction of a new, 2 storey, 2 classroom building at Patani Elementary School in Barangay Patani, Marawi City, Lanao del Sur.

This school was badly damaged by the siege in 2017 and it was to this particular school that the community ran for safety during the war due to its close proximity to the City's business epicenter. Patani Elementary School is populated by Muslims (Maranao) and Christians and they needed new classrooms to accommodate more students, especially as more displaced people were returning to Marawi City.

On June 29, 2020, the new Kapuso school and a concrete stage were inaugurated, just 3 months after the nationwide COVID lockdown was implemented. Despite the quarantine, construction continued unabated with the support of The Coffee Bean & Tea Leaf, the AFP-Western Mindanao Command, the Philippine Army's 1st Infantry Division, the 103rd Infantry Brigade, the 55th Engineer Brigade and the 551st Engineer Battalion.

When we rebuild a City, we not only rebuild infrastructure but also the shattered lives of those who are able to find hope again through the kindness of others. The public's generous support made the rebuilding of Marawi City's dreams happen!



Datu Saber Elementary School

Barangay Datu Saber, Marawi City, Lanao del Sur

GMA Kapuso Foundation's Rebuild Marawi project worked towards post-conflict reconstruction for sustainable peace. It aims to foster integral education by providing decent and functional classrooms with water distribution and sanitation facilities to thousands of public elementary students and teachers in Marawi City, Lanao del Sur.

Thus, we took on the challenge of building our 3rd school in this war torn City. The Rebuild Marawi Project: Datu Saber Elementary School is a 7-classroom 3-storey school building complex at Barangay Datu Saber with 6 segregated boys and girls' restrooms, a stage, a library, a canteen, a vertical vegetable garden and handwashing facilities.

GMA Kapuso Foundation tapped the Embassy of Japan (EOJ) in the Philippines for funding through its Grant Assistance for Grassroots Human Security Project. We also partnered with the United Architects of the Philippines-Emergency Architects for the space saving, well lighted and ventilated multi storey school design to maximize the limited space. We also tapped the Armed Forces of the Philippines in the project implementation. Specifically, the AFP Western Mindanao Command, the 1st Infantry Division, the Philippine Army's 55th and 54th Engineering Brigades.

One of the great challenges that we had to overcome was securing the land title of the school which was a requirement of the EOJ to approve our grant application. Through the former Department of Environment and Natural Resources (Provincial and City) which is now named the Ministry of Environment, Natural Resources and Energy-BARMM, we sought the help of the provincial local

government unit (PLGU) of Lanao del Sur who owned the lot of Datu Saber Elementary School. The land was successfully titled and donated by the PLGU to the then Department of Education – Marawi City which is now the Marawi City Ministry of Basic, Higher & Technical Education.

Other partners for the construction of the school include Task Force Bangon Marawi, the Department of Public Works and Highways, Republic Cement and the Manila Water Foundation. The Marawi City local government also committed to the repair and maintenance of the school.

Partners engaged for the amenities, furniture and fixtures are the following:

The Coffee Bean & Tea Leaf donated the vertical vegetable garden, the library's furniture and upcycled armchairs & tables made from 100% single use plastic.

Rayomar Outreach Foundation gave complete sets of textbooks for students Grades 3-6.

Envirotech supplied the recycled plastic furniture and gave discounted rates.

Adarna House donated culturally sensitive storybooks for the library.

Manila Water Foundation constructed a handwashing facility and boy's and girl's restrooms located across the school for the convenience of learners and teachers who use the classrooms at the ground floor.



The construction of Datu Saber Elementary School began soon after the groundbreaking ceremony on June 14, 2019. The new innovative building was constructed in only 266 calendar days, considering all the weather constraints, political and logistical challenges.

Unfortunately, a tornado hit Marawi City in December 2020 which destroyed the temporary learning school nearby where the students and teachers of Datu Saber Elementary School were holding classes while the new school was being constructed. GMA Kapuso Foundation sought permission from the EOJ to turnover the new school building with amenities, furniture and fixtures to the community on December 20, 2019 so they can safely use the sturdy structure until the official inauguration is conducted after a required thorough audit by the EOJ.

Finally on November 25, 2020, Datu Saber Elementary School was officially inaugurated. The new 3-storey smart space school building is resilient to typhoons, earthquakes and bullets. The bright classrooms are well ventilated by electric ceiling fans and furnished with water dispensers all provided by Hanabishi Appliances. Segregated toilets for boys and girls with handwashing facilities ensure proper sanitation. In addition, a library, canteen, stage and vertical vegetable garden make this school truly one of its kind. This multi-storey building maximizes the limited space with sufficient areas for school activities. Over 300 enrolled students and 17 teachers currently use this school.

The completion of the Rebuild Marawi project at Datu Saber Elementary School is a poignant symbol of unity among Christians and Muslims who worked together despite of differences in religious beliefs to reach one goal of laying the foundation of education. The construction of the new school also symbolizes the unity of both Japanese and Filipino cultures as we share the mission of alleviating poverty for internally displaced persons in Marawi City. It strengthened the bilateral relations of Japan and the Philippines by providing a vital post conflict resolution through education.

Cabatangan Elementary School

Barangay Cabatangan, Zamboanga City

GMA Kapuso Foundation pushes through challenges to provide sturdy Kapuso schools amidst the economically brutal COVID pandemic.

At Cabatangan Elementary School in Zamboanga City, the community was forced to share the barracks of the 54th Engineer Brigade, Philippine Army for the use of a pre-school, madrasah (Islam school) and classes for Alternative Learning (ALS).

GMA Kapuso Foundation saw the need to provide new classrooms to this Tausug Muslim community especially since GMA Network built a television relay station also in Cabatangan. The construction of a multipurpose building began on Sept. 21, 2020 and was finished on November 12, 2020 in partnership with the Philippine Army's 54th Engineer Brigade and the Alpha Sigma Phi Philippines- Samboangan Alumni Association. On November 14, 2020, GMA Kapuso Foundation inaugurated a multipurpose building with 2 Kapuso type classrooms.

Now, the grateful community enjoys their spacious new building, thanks to the big hearts of multisectoral partners who prioritize the dire needs of others above themselves.



Kapuso Tulay Para Sa Kaunlaran Ng Pansur

Barangay Pansur, Salvador, Lanao del Norte

GMA Kapuso Foundation's Kapuso Tulay Para Sa Kaunlaran Project aims to connect remote communities to trade and learning centers through the construction of sturdy steel and concrete hanging bridges. This project also serves as a disaster relief intervention to disaster prone areas.

An old bridge at Barangay Pansur, Salvador, Lanao del Norte was completely destroyed by Typhoon Vinta in 2017 which claimed the lives of 23 residents including 9 children. Since then, the community of Muslims (Tausug) and Christians who reside here was forced to cross the treacherous river by foot or by using their local transportation called Payong Payong which is a tricycle that utilizes an umbrella for shade.

GMA Kapuso Foundation saw the need to build a sturdy bridge for this community to cut their long commute to the market and to nearby schools. On October 9, 2020, a new 40 meter steel and concrete hanging bridge was inaugurated. This is GMA Kapuso Foundation's fifth bridge, constructed with the help of the Philippine Army's 54th Engineer Brigade.

Now, the traumatized residents feel safe and secure. Some, whose homes were wiped out by Typhoon Vinta, are planning to move back because of the new Kapuso bridge.

Tragedies strike for a reason. As painful as they are, they teach us to value who and what matter the most: Family, community and to always keep the hope that even the most dire situations will get better.



Bisig Bayan Health Projects 2020

Bisig Bayan Medical Assistance

Prior to the lockdown in March 2020, GMA Kapuso Foundation gave free medicine, laboratory exams and other medical services to 211 patients from January to February. To adhere to strict COVID safety protocols, patients were asked to email their requests then GMAKF staffers would call them for a more detailed assessment. Upon GMAKF management approval, a pledge form is picked up by the beneficiary or an authorized representative (if beneficiary is incapacitated) at the lobby of the KF office so they can purchase medicine and avail of the free laboratory exams and medical services. Face to face consultations and assessments were jettisoned in 2020.

Goiter Awareness Month

In observance of the Department of Health's Goiter Awareness month in January, GMA Kapuso Foundation served 307 patients from Sta. Cruz, Manila who were given free medical assistance to prevent and control Goiter due to iodine deficiency. They also attended a lecture about thyroid awareness and underwent thyroid screening to prevent goiter and other Iodine Deficiency Disorders.

Goiter is the enlargement of the thyroid gland due to iodine deficiency or other causes such as autoimmune diseases, inflammation and other medical conditions. Goiter can be prevented by consuming food rich in iodine and by the regular and adequate use of iodized salt. Let us continue to prevent and beat this disease by spreading awareness; observing the proper diet; and getting timely treatment!

FEBRUARY

Ngiting Kapuso

A smile says a thousand words. GMA Kapuso Foundation's Ngiting Kapuso project gave radiant smiles and new confidence to 191 needy beneficiaries from the National Capital Region through the provision of complete and partial dentures. This project was made possible through the following partners: the Philippine Association of Private School Dentists, the Centro Escolar University School of Dentistry and Nilo Dental Laboratory. By sharing the mission of alleviating poverty, we serve more Filipinos who need help with seeking gainful employment!



JULY

Linis Lusog Kapuso Ng Kabataan

The observance of proper hygiene is crucial so we can live healthy lives. This is especially true in the time of COVID-19. This year in July, GMA Kapuso Foundation served 760 Kindergarten and Grade 1 public elementary students from Guimba, Nueva Ecija through the Linis Lusog Kapuso Ng Kabataan project.

Hygiene kits containing toothbrush, toothpaste, soap, shampoo, mouthwash and lice haircare treatment and face masks were distributed to these children. They also availed of free dental services and tooth extraction. Handwashing and hygiene lectures were also held to create awareness on the importance of observing good hygiene for physical and mental health.

The teachers and parents attended the activity. The parents picked up the hygiene kits and attended the lectures. They also participated in the handwashing and hygiene demonstrations. With parental consent, around 200 children were administered fluoride varnish to strengthen their permanent teeth. This was done in batches of 20 kids in keeping with AntiCOVID protocols.

National Disability Prevention and Rehabilitation Week

GMA Kapuso Foundation believes in the capability of the handicapped to lead productive lives and contribute to society.

In celebration of the National Council on Disability Affairs' National Disability Prevention and Rehabilitation Week in July, GMA Kapuso Foundation gave wheelchairs to 47 indigent persons with physical disabilities from the National Capitol Region, Rizal, Cavite, Laguna and Bulacan.

This project was made possible through the vital help of our partners, NKD Trading who donated the wheelchairs and the Philippine Army who provided transportation and security for the distribution of the wheelchairs.

Health Feature: **Our Mission, Their Vision**

She takes a picture of her reading material. She then zooms it in on her cellphone. That's the only time Grade 7 student from Caramoan, Camarines Sur Kim Angela can actually see what she's reading. Kim is suffering from corneal dystrophy, a rare eye disease where abnormal material builds up in the cornea, the clear, front window of the eye, clouding a person's vision.

Kim is the youngest of four of the Clores siblings. She has two brothers and a sister. Unfortunately, her two brothers, Roildan and Rayven, had the same eye disease. The brothers had to use a magnifying glass and a flashlight as reading aids.

For the Clores siblings, they just didn't have a tough time with their vision, their self-esteem and social life were badly affected as well. Nobody wanted to be friends with them. They themselves didn't want to go out and be with their peers.

GMA Kapuso Foundation met the Clores siblings when they were just little kids back in 2011. We constantly monitored their condition and gave them medicines, eye drops to alleviate their eye problem and vitamins as we were waiting for possible donors for an operation. We eventually partnered with the Eye Bank Foundation of the Philippines and in 2012 and 2017, Roildan and Rayven's vision were restored through a corneal transplant.

Fast forward to 2020, GMAKF visited the Clores siblings again. We are elated to see the brothers performing great in school, even bagging several medals for their academic excellence. They also got their self-confidence back, gaining new friends in school and in the neighborhood. The visit was aired on Kapusong Totoo segment of 24 Oras.

2020 also marked the 25th anniversary of our long-time partner the Eye Bank Foundation of the Philippines.

As for Kim Angela, she is being closely monitored as she now developed the worst condition of the three. She is due for a corneal transplant and is awaiting the availability of a compatible cornea. It is GMAKF's mission to see her eyes smiling with hope again.



Health Feature:

'Serbisyong Totoo' To The Bone

GMA Kapuso Foundation met three siblings in Tayabas, Quezon. They can hardly stand and are always lying down. They have very limited movement. Valeña sisters Angel (17), Chrezel (13) and Princess (5) are all suffering from osteogenesis imperfecta, a genetic disorder that prevents the body from building strong bones. It's also known as 'brittle bone disease' as it results in bones that break easily.

Angelito and Rosalie Valeña have six children, four of which are afflicted with the disease. Unfortunately, one of the four has passed away last 2010. As parents, they are doing their best for Angel, Chrezel and Princess to have normal lives but their finances are a big handicap – Angelito works as a driver and Rosalie stays at home to watch over the kids.

In 2020, GMAKF partnered with Latter-Day Saint Charities, the UP College of Allied Medical Professions and the Philippine Society of Wheelchair Professionals and provided the sisters with fully-customized wheelchairs. We had to study the girls' postures and brittle bone builds. Since they have different conditions, we had to measure and design the wheelchairs' dimensions to fit each one of them. String, straps and carved foam were added to keep them comfortable and secure.

Aside from the wheelchairs, we also gave them Kapuso grocery packs, diapers, egg crate mattresses for more comfort in their sleep, milk and bags with school supplies. The visit was aired on Kapusong Totoo segment of 24 Oras.

The wheelchairs made Angel, Chrezel and Princess very excited to go out and move about. And GMAKF proud and fulfilled...to the bone.



UHSK 2021: Unang Hakbang Sa Kinabukasan Supports On-line Education Amidst the COVID-19 Pandemic

COVID-19 caused the late start of school year 2020 and when it did begin in August, students, parents and teachers, all had to cope with the bewildering and sudden change from traditional face to face classes to on-line classes. Many parents, saddled with restrictions on their earning capability and needing to spend additionally on cellular phone/mobile load and WI-FI for their children's gadgets, had very little to nothing to spare on important support materials. GMAKF filled the void by providing kinder to Grade 1 students with a complete set of school supplies for their studies. 70 thousand school children from needy families in 922 public elementary schools, nationwide, received sturdy school bags laden with (5) writing notebooks, (2) intermediate pad papers, (2) jumbo pencils, a box of (1) crayons, a double sharpener and an Anti-Covid kit with (2) soaps, (2) bottles of rubbing alcohol and (2) washable facemasks.

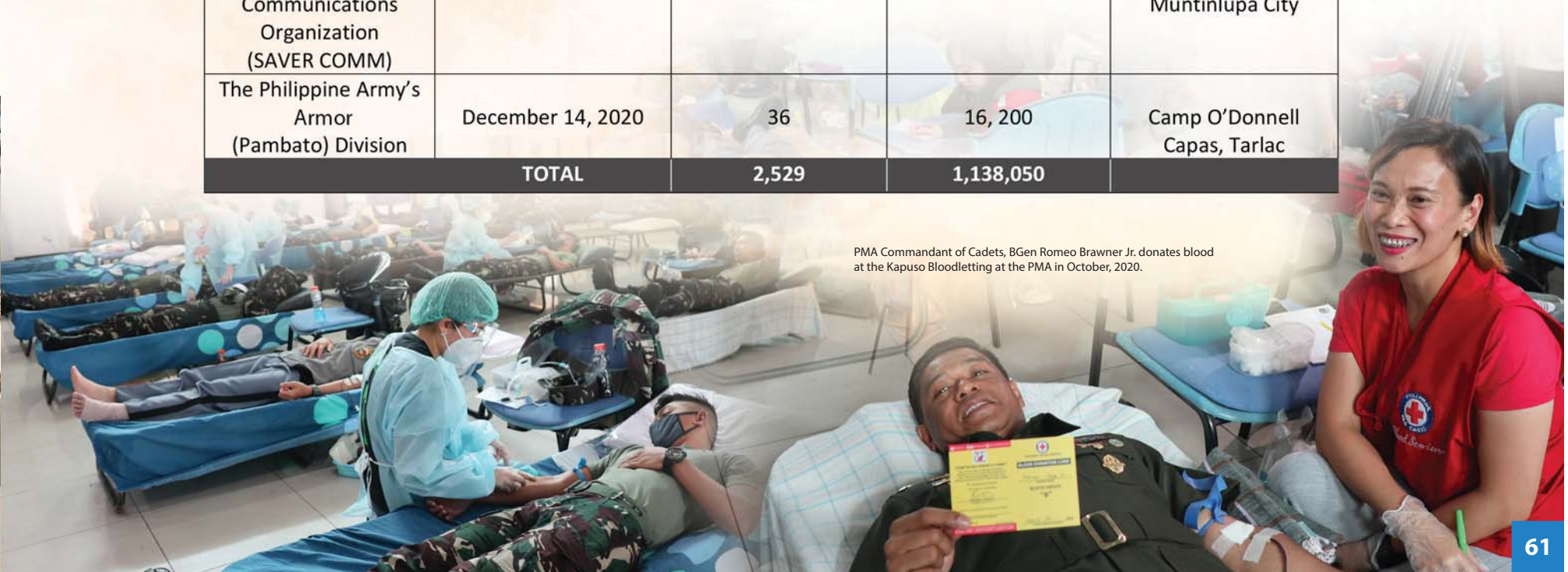

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of GMA Kapuso Foundation, Inc. (a nonstock, nonprofit organization) (the Foundation), which comprise the statements of assets, liabilities and fund balance as at December 31, 2020 and 2019, and the statements of receipts and expenses, statements of changes in fund balance and statements of cash flows for the years then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Foundation as at December 31, 2020 and 2019, and its financial performance and its cash flows for the years then ended in accordance with Philippine Financial Reporting Standards for Small and Medium-sized Entities (PFRS For SMEs).

Basis for Opinion

We conducted our audits in accordance with Philippine Standards on Auditing (PSAs). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Foundation in accordance with the Code of Ethics for Professional Accountants in the Philippines (Code of Ethics) together with the ethical requirements that are relevant to our audit of the financial statements in the Philippines, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with PFRS for SMEs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Foundation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Foundation's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Foundation to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

An asset is classified as current when it is:

- Expected to be realized or intended to be sold or consumed in normal operating cycle;
- Held primarily for the purpose of trading;
- Expected to be realized within twelve months after the reporting period; or
- Cash and cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

A liability is classified as current when:

- It is expected to be settled in normal operating cycle;
- It is held primarily for the purpose of trading;
- It is due to be settled within twelve months after the reporting period; or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

The Foundation classifies all other assets and liabilities as noncurrent.

Basic and Other Financial Instruments

The Foundation accounts for its financial instruments in accordance with Section 11, *Basic Financial Instruments*, under PFRS for SMEs.

Initial Recognition and Measurement. Basic and other financial assets and liabilities are recognized when the Foundation becomes a party to the contracts. Basic financial instruments are measured at transaction price including transaction costs. If the contract constitutes a financing arrangement, it is measured at the present value of future payments discounted at a market rate of interest for a similar instrument, unless the assets and liabilities are classified as current and do not incorporate a finance arrangement. If interest is not at a market rate, the fair value would be future payments discounted at a market rate of interest. Other financial instruments are initially measured at fair value, which is usually their transaction price, and exclude transaction costs.

Subsequent Recognition. For basic financial instruments, at the end of each reporting period:

- Debt instruments, such as an account, note, or loan receivables or payables, are measured at amortized cost using the effective interest rate;
- Commitments to receive a loan are measured at cost less impairment; and
- Investments in non-convertible preferred shares and non-puttable ordinary, and preference shares that are publicly traded or their fair value can otherwise be reliably measured, are measured at fair value through profit and loss if a public market exists, otherwise at cost less impairment.

All other financial instruments are measured at fair value at the end of each reporting period, except for equity instruments (and related contracts that would result in delivery of such instruments) that are not publicly traded and whose fair value cannot be reliably determined, which are measured at cost less impairment.

As at December 31, 2020 and 2019, the Foundation's basic financial instruments consist of cash and cash equivalents, short-term investments, receivables, accounts payable and other current liabilities (excluding payable to government agencies) and due to a related party. The Foundation has no other financial instruments measured at fair value.

NOTES TO FINANCIAL STATEMENTS

1. Corporate Information

GMA Kapuso Foundation, Inc. (the Foundation) was incorporated in the Philippines and registered with the Philippine Securities and Exchange Commission (SEC) on April 24, 1991 as a nonstock, nonprofit organization under the laws of the Republic of the Philippines. The primary activity of the Foundation is to engage in philanthropic, humanitarian and charitable activities for public welfare. The registered office address of the Foundation is GMA Network Center EDSA corner Timog Avenue, Brgy. South Triangle, Diliman, Quezon City.

As a nonstock, nonprofit organization, the Foundation is exempt from income tax under the conditions set forth in Section 30 (E) of the National Internal Revenue Code (NIRC).

On August 23, 2018, the Philippine Council for NGO Certification (PCNC) renewed its accreditation to the Foundation valid for five (5) years from August 23, 2018 to August 22, 2023.

On July 9, 2019, the BIR issued a Certificate of Registration (COR) to the Foundation, being duly accredited by PCNC, as a donee institution in accordance with the provisions of Revenue Regulations (RR) No. 13-98 dated December 8, 1998. Accordingly, donations received by the Foundation shall entitle donors to the full or limited deduction pursuant to Section 34 (H)(1) or (2) and exemption from donor's tax pursuant to Section 101 (A)(2) of the NIRC of 1997, as amended. This certification is valid until January 24, 2021 unless sooner revoked by the BIR for the violation of any provisions of RR No. 13-98 or upon withdrawal of the certificate of accreditation by PCNC.

On September 17, 2020, the Bureau of Internal Revenue (BIR) renewed the Foundation's Certificate of Tax Exemption from income tax only on the revenues or receipts from projects and donations valid for three (3) years from September 17, 2020 to September 16, 2023.

The accompanying financial statements of the Foundation were approved and authorized for issuance by the Board of Trustees on March 26, 2021.

2. Basis of Preparation, Statement of Compliance and Summary of Significant Accounting Policies

Basis of Preparation

The financial statements have been prepared on the historical cost basis. The financial statements are presented in Philippine Peso, which is the Foundation's functional and presentation currency. Amounts are rounded off to the nearest peso, except when otherwise indicated.

Statement of Compliance

The financial statements have been prepared in accordance with the Philippine Financial Reporting Standards for Small and Medium-sized Entities (PFRS for SMEs).

Current versus Noncurrent Classification

The Foundation presents assets and liabilities in statement of financial position based on current/noncurrent classification.

Determination of Fair Value. The standard makes use of a fair value hierarchy such as quoted prices in an active market, prices in recent transactions for the identical assets (adjusted if necessary), and use of a valuation technique (that reflects how the market would expect to price the asset and the inputs reasonably represent market expectations). Fair value, where there is no active market, is only considered reliable if the variability in the range of fair values is not significant and the probabilities of various estimates can be reasonably assessed. Fair value of a liability cannot be below the amount in a demand feature discounted to the reporting period. For all other financial instruments not listed in an active market, the fair value is determined by using appropriate valuation techniques. Valuation techniques include using arm's length transaction for an identical asset between knowledgeable, willing parties, if available, reference to current fair value of another asset that is substantially the same as the asset being measured, discounted cash flow analysis, option pricing models and other relevant valuation model.

Impairment. At the end of each reporting period, an assessment is made as to whether there is objective evidence of a possible impairment. If there is objective evidence of impairment, the Foundation shall recognize an impairment loss in the statement of receipts and expenses immediately.

All equity instruments regardless of significance and other financial assets that are individually significant shall be assessed for impairment individually and all other financial assets shall be assessed for impairment either individually or grouped on the basis of similar credit risk characteristics. The impairment loss of basic financial instruments at amortized cost is the difference between carrying value and the revised cash flows discounted at the original effective interest rate. The impairment loss of basic financial instruments at cost less impairment is the difference between the carrying value and best estimate of the amount that would be received if the asset were sold at the end of each reporting period.

If, in a subsequent period, the amount of an impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognized (such as an improvement in the debtor's credit rating), the Foundation shall reverse the previously recognized impairment loss either directly or by adjusting an allowance account. The Foundation shall recognize the amount of the reversal in the statement of receipts and expenses immediately.

Other financial instruments carried at cost less impairment are impaired on the same basis as basic financial instruments measured in the same manner.

Derecognition. The Foundation derecognizes a financial asset when:

- The contractual rights to the cash flows from the financial asset expire or are settled;
- The Foundation transfers to another party substantially all of the risks and rewards of ownership of the financial asset; or
- The Foundation, despite having retained some significant risks and rewards of ownership, has transferred control of the asset to another party and the other party has the practical ability to sell the asset in its entirety to an unrelated third party.

The Company derecognizes financial liabilities when:

- it is extinguished, i.e., when the obligation specified in the contract is discharged, is cancelled or expires; or
- profit and loss is recognized between the carrying amount of the financial liability extinguished or transferred to another party and the considerations paid, including any non-cash assets transferred or liabilities assumed.





Cash and Cash Equivalents

Cash includes cash on hand and in banks. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash with original maturities of three months or less and that are subject to an insignificant risk of change in value.

Short-term Investments

Short-term investments include highly liquid investments that are readily convertible to known amounts of cash with original maturities of more than three months but less than one year from dates of acquisition and subject to an insignificant risk of change in value.

Other Current Assets

Other current assets include medical insurance paid in advance and amortized over the term of the contract.

Property and Equipment

Property and equipment are stated at cost less accumulated depreciation and any impairment in value.

The initial cost of property and equipment comprises its purchase price and other costs directly attributable in bringing the asset to its working condition and location for its intended use.

Expenditures incurred after the property and equipment have been put into operation, such as repairs and maintenance, are normally charged as expense in the year such costs are incurred. In situations where it can be clearly demonstrated that the expenditures have resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property and equipment beyond its originally assessed standard of performance, the expenditures are capitalized as additional costs of property and equipment.

Depreciation is computed using the straight-line method, net of any estimated residual value, over the estimated useful lives of the assets, as follows:

If there is an indication that there has been a significant change in depreciation method, useful life or residual value of an asset, the depreciation of that asset is revised prospectively to reflect the new expectations.

An item of property and equipment is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising from derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is credited or charged to current operations in the year the asset is derecognized.

Fully depreciated assets are retained in the accounts until these are no longer in use and no further depreciation is charged to current operation.

Impairment of Property and Equipment

At each reporting period, property and equipment is reviewed to determine whether there is any indication that those assets have suffered an impairment loss. If there is an indication of possible impairment, the recoverable amount of any affected asset (or group of related assets) is estimated and compared with its carrying amount. If estimated recoverable amount is lower, the carrying amount is reduced to its estimated recoverable amount, and an impairment loss is recognized immediately in the statement of receipts and expenses.

If an impairment loss subsequently reverses, the carrying amount of the asset (or group of related assets) is increased to the revised estimate of its recoverable amount, but not in excess of the amount that would have been determined had no impairment loss been recognized for the asset (or group of related assets) in prior years. A reversal of an impairment loss is recognized immediately in the statement of receipts and expenses.

Other Noncurrent Asset

Other noncurrent asset pertains to restricted cash in bank of the Foundation.

Accounts Payable and Other Current Liabilities

Accounts payable and other current liabilities are obligations on the basis of normal credit terms and do not bear interest. These are recognized in the period in which the related money, goods or services are received or when a legally enforceable claim against the Foundation is established or when the corresponding assets or expenses are recognized.

Fund Balance

Fund balance represents the cumulative balance of the excess of receipts over expenses.

Restricted Fund Balance. Restricted fund balance results from contributions for which donor imposed restrictions limit the Foundation's use of an asset or its economic benefits.

Unrestricted Fund Balance. Unrestricted fund balance generally results from revenue and other income that are derived from the Foundation's regular operations unless the receipts are limited by donor-imposed restrictions. The Foundation's expenses are reported as decreases in unrestricted net assets.

Revenue Recognition

Revenue comprises of donations, receipts for projects and interest income (collectively referred to as "receipts"). Revenue is recognized to the extent that it is probable that the economic benefits associated with the transaction will flow to the Foundation and the amount can be reliably measured. The following specific recognition criteria must also be met before revenue is recognized:

Projects and Donations. Projects are amounts received to fund specific program of the Foundation. Donations are general fund that is used to finance any program, including medical assistance of the Foundation. Projects and donations are recognized when it is probable that the economic benefits associated with the donation will flow to the Foundation, which in most cases is upon receipt of the donation from the donors. Donations in-kind are given to designated donees immediately.

Interest Income. Revenue is recognized as the interest accrues, taking into account the effective yield on the asset.

Expenses

Expenses are recognized when a decrease in economic benefit related to a decrease in an asset or an increase of a liability has arisen that can be measured reliably.

Project costs and donation expenses are recognized on the basis of a direct association between the cost incurred and revenue recognized by the Foundation.

Pension Costs

The Foundation has a funded, noncontributory retirement plan covering its permanent employees. Pension costs are actuarially determined using the projected unit credit method. The projected unit credit method considers each period of service as giving rise to an additional unit of benefit entitlement and measures each separately to build up the final obligation. Actuarial gain or loss and past service costs are recognized immediately in the statement of receipts and expenses. Gains or losses on the curtailment or settlement of pension benefits are recognized when the curtailment or settlement occurs.

Foreign Currency-denominated Transactions

Foreign currency gains and losses are reported on a net basis. Transactions in foreign currencies are recorded using the closing exchange rate at the dates of transactions. Monetary assets and liabilities denominated in foreign currencies are restated using the closing exchange rate at the reporting period. All differences are taken to the statement of receipts and expenses. Nonmonetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates as at the dates of the initial transactions.

Provisions

Provisions are recognized when the Foundation has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Where the Foundation expects a provision to be reimbursed, the reimbursement is recognized as a separate asset but only when the receipt of the reimbursement is virtually certain.

Contingencies

Contingent liabilities are not recognized in the financial statements. These are disclosed unless the possibility of an outflow of resources embodying economic benefits is remote. Contingent assets are not recognized in the financial statements but are disclosed when an inflow of economic benefits is probable.

Events after the Reporting Period

Post year-end events that provide additional information about the Foundation's financial position at the reporting period (adjusting events) are reflected in the financial statements. Post year-end events that are not adjusting events are disclosed in the notes to financial statements when material.

3. Significant Accounting Judgments, Estimates and Assumptions

The preparation of the Foundation's financial statements in conformity with PFRS for SMEs requires the management to make judgments, estimates and assumptions that affect the amounts reported in the financial statements and related notes. Future events may occur which may cause the assumptions used in arriving at the estimates to change. The effects of any change in estimates are reflected in the financial statements as these become reasonably determinable.

Judgments, estimates and assumptions are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Judgment

Management makes judgments in the process of applying the Foundation's accounting policies. Judgment that has the most significant effect on the reported amounts in the financial statements is discussed below.

Determination of Restricted and Unrestricted Receipts and Expenses. The Foundation reports receipts as restricted if these were received with donor stipulation that limits the use of the donation, otherwise it will be classified as unrestricted. Program expenses are classified as restricted following the classification of the related receipts. Should the receipts from restricted be inadequate to fund the program expenses, then the Foundation would assess whether it needs to obtain funds from the unrestricted receipts.

Restricted receipts/revenue and program expenses amounted to ₱52,022,941 and ₱39,587,661 in 2020 and ₱28,440,872 and ₱23,577,293 in 2019, respectively (see Notes 9 and 11). Unrestricted receipts/revenues, and program and administrative expenses amounted to ₱150,834,207 and ₱75,094,341 in 2020 and ₱43,999,785 and ₱75,029,017 in 2019, respectively (see Notes, 9, 10 and 11). The accumulated restricted and unrestricted fund balance amounted to ₱27,072,450 and ₱166,587,964 as at December 31, 2020 and ₱14,637,170 and ₱90,848,098 as at December 31, 2019, respectively.

Estimates and Assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting period, that have a significant risk causing a material adjustment to the carrying amounts of assets and liabilities, within the next financial year, are described below.

Assumptions on Pension Costs. The determination of the Foundation's pension liability and pension costs is dependent on the selection of certain assumptions used by actuaries in calculating such amounts. Those assumptions are described in Note 13 and include, among others, discount rate and expected rate of salary increase. Actual results that differ from the assumptions are accumulated and recognized in the period in which it occurs.

Pension liability amounted to ₱3,430,462 and ₱2,774,941 as at December 31, 2020 and 2019, respectively (see Note 13).

- Operation Bayanihan - a quick relief response to victims of natural and man-made disasters anywhere in the country.
- Kapuso School Rehabilitation/Development - includes a school-based program and reconstruction of demolished bridges.

School-based program aims to foster integral education to provide students of underserved public schools, both primary and secondary, of the following:

- Decent and functional classrooms which are conducive for learning;
- Water distribution and sanitation facilities; and
- Environmental awareness through tree-planting around the school building.

Reconstruction of demolished bridges program aims to connect remote communities to trade and learning centers.

- Unang Hakbang sa Kinabukasan - yearly school opening project for incoming Grade 1 students from poor and remote public elementary schools nationwide where they receive backpacks with complete set of school materials.
- Give a Gift (GAG) - the yearly distribution of customized Christmas packages to underprivileged children from poor and far-flung areas. To address specific needs of some of these children, the GAG evolved into sub-projects such as the GAG: Feeding, GAG: Surgical, GAG: Cancer Kid and GAG: Distribution.
- Kalusugan Karavan - a roving medical mission in far-flung areas where basic health services are not accessible.
- Bisig Bayan - special projects in line with the monthly themes of the Department of Health such as Ngiting Kapuso, Serbisyong Alay Sa Kababaihan, Operation Tuli, Serbisyong Alay Sa Kalalakihan, Wheelchair and Hearing Aid Giving, Kapuso 20/20, Echocardiogram Testing, and Blood Sugar Testing.
- Sagip Dugtong Buhay - an annual bloodletting project which promotes volunteerism by donating blood to help save lives and extend the lives of others.
- Linis Lusog Kapusong Kabataan - aims to promote and teach students, teachers and parents of proper hand washing, oral hygiene, nail cutting and head lice treatment.

13. Pension Liability

The Foundation has a funded, non-contributory retirement plan covering its permanent employees. In 2020 and 2019, the Foundation contributed to a retirement fund managed by a trustee bank.

Under the existing regulatory framework, Republic Act 7641 requires a provision for retirement pay to qualified private sector employees in the absence of any retirement plan in the entity, provided however that the employee's retirement benefits under any collective bargaining and other agreements shall not be less than those provided under the law. The law does not require minimum funding of the plan.





Under PFRS for SMEs, the cost of defined benefit obligations, including those mandated under Republic Act 7641 should be determined using an accrued benefit valuation method or projected benefit valuation method to be determined by an independent actuary.
